

**ACSAA EXECUTIVE BOARD MEETING**

The executive board meeting was called to order by President Rudy Schuster at 6:20 P.M.

Minutes of the annual meeting of the Afton Central School Alumni Association were read and approved.

### **Treasurer's Report**

### **Membership**

Charlie Davis reported 100 members in 2004 and we now stand at 222 members. Our membership term is from July to July. Some members are paid up for multiple years. We have 160 members already paid for 2006. A suggestion was made to offer lifetime memberships. A lengthy discussion was held on the range of membership. The subject of membership was tabled until our next meeting. Membership could also be gifted for a period of time. Delegates might be involved in a membership drive. This was tabled for further discussion.

### **Website**

Scott asked for database updates from Judy and Charlie Davis and others. Scott reviewed the web page site and its many applications such as membership, message page, list of officers, news, class directory, annual class reunion and other links. A discussion followed on whether non-members of ACSAA be listed as non-members in the future newsletter. The newsletter will not be published in its entirety in the next issue. This might entice non-members to join and receive the newsletter in full.
